U.S. Customs Duty Payments

Prior to the imposition of the increased duties, Dimerco and other Customs brokers were willing to advance Customs duties for their clients without charge. However, this practice was based on average U.S. duty rates of about 3%. The increased tariffs have put an extreme financial burden on U.S. Customs brokers and have required us to make very large cash advances for Customs duties. In order to cover the cost of these large duty advances, Dimerco finds itself compelled to follow the lead of other U.S. Customs brokers in imposing a Duty Advance Fee of 2% of all duties advanced on our customers' behalf. We regret having to impose this charge, but we have to deal with the increased costs we are incurring.

Option 1

• Dimerco Express (U.S.A.) Corp. will advance U.S. Customs payments (duties, taxes and fees) on my behalf and will include those charges on the transaction invoice. Please note, if you request Dimerco Express (U.S.A.) Corp. to fund duty payments on your behalf a 2% Duty Advance Fee will be applied based on the advance amount. By choosing this option, you authorize Dimerco Express (U.S.A.) Corp.to make payment to U.S. Customs via broker Periodic Monthly statement (PMS.) This fee will become effective for entries made on or after Aug. 1, 2019 and is due and payable within 7 days of the date we file your entry. Where payments are not received by close of the 7th day after entry, we may elect not to advance any duties, taxes, and fees on your behalf, in which case you will be responsible for paying such charges to Customs. Late payments will be charged interest at 1.5% per month.

Option 2
